

WOMEN'S EDUCATION

NEED OF WOMEN'S EDUCATION:

- a) Educating the women will empower them to seek gender equality in the society.
- b) Women will be able to earn that would raise their economic condition and their status in the society.
- c) They will be aware about the advantages of small and planned family and this will be a big step towards achieving stabilized population goals.
- d) It has been reported that the single most important factor affecting high total fertility rates (TFR) is the low status of women in many societies. Women education will help increase the age of marriage of women and they would tend to have fewer, healthier children who would live longer.
- e) Women on being educated would be able to rear their children in a better way, leading to their good health and provide them with better facilities.
- f) Women are also the victim of capitalism and development. Due to some development activity like dam building or mining, they get rehabilitated. The men folk get some compensation and migrate to towns in search of some job while women are left behind to look after the family with little resources. They are compelled to take up some marginalized work, which is highly unorganized and often socially humiliating. Women education can greatly help restore their settlement and dignity.
- g) Education of women would mean narrowing down of social disparities and inequities.

 This would automatically lead to sustainable development.

- 1. A Student requires to Submit
- 2. Filled Application Form with 3 nos of Passport size Photos
- 3. Educational Document(s) having passed the Qualifying or Equivalent Examination
- 4. The School Leaving Certificate / Transfer Certificate signed by the Head of the Institution last attended and countersigned
- 5. Aadhaar Card Copy
- 6. Course Fee in the Form of Demand Draft

Cancellation of Admission:

- 1. The Admission will be cancelled & the Fee will be forfeited on the following grounds:
- 2. Incomplete application form
- 3. Lack of required educational qualification
- 4. Required document of age, qualification and experience are not attached
- 5. ID/Address proof missing
- 6. Not eligible for current session
- 7. Fee due

Examination & Evaluation Procedure:

AIMS conducts the Examination for Vocational Courses twice in a year. In addition to that, it is also proposed to offer On-Demand Examination in case the number of students at any AIMS centres is more than 50. The Evaluation System has been devised to test the skills in a comprehensive manner giving more emphasis on the Internship Component

General instruction to the Students:

- Before submitting the Filled in Application, the candidates should ensure their eligibility for Admission to the Programme for which they would like to apply.
- The candidates should clearly specify, the Course they have opted for, in the application.
- All fees should be paid in the form of Demand Draft only, drawn in favour of "All India Mahila Sangh" payable on any one of the nationalized banks at Chennai.
- The candidates should write their
 (i)Name (ii) Application number and (iii) Programme opted on the reverse of the Demand Draft.
- Payment of fees in instalment is not permitted, except where the course is of 2 years duration. It is to be noted that the student has to pay the fees specified for each year in full.
- Fees once paid shall neither be refunded nor be adjusted towards any other payment.
- Cash / Cheques will not be accepted under any circumstances.
- Students should fill-up the application form in block letters in his/her own handwriting and duly sign in the space provided.
- Incomplete applications and over-written applications will be summarily rejected.
- Admission to any course cannot be claimed as a matter of right.
- Before submitting the application to the Centre / Council, the applicant should make note of the application number.
- Candidates should not register for two programmes in the same year.
- Change of Name / Study Centre will not be permitted.
- The Council reserves the right not to conduct any of the programmes if the circumstances warrant.
- There will not be any separate communication from the Centre / Council for payment of second year course fees. The second year fees has to be paid whether the candidate has taken up the examinations or not /results declared or not.
